GUIDELINES FOR PAPERS

Conceptual, empirical papers and case studies are invited for presentations from academicians, research scholars, students, practitioners and industry representatives from various disciplines on any of the themes.

Mail the final paper to the conference email: including an abstract, an indication of purpose of research, methodology proposed, outcome implications and major references.

The abstract (maximum 300 words) and full paper should not exceed 3500 words, excluding tables, graphs and diagrams. Font to be used for the final paper would be Times New Roman, font size of 12 points and 1.5 line spacing. Allow margin of 1inch on all four sides. Use MS-Office format only and follow APA style of referencing. Certificate of Originality and Transfer of Copyright form must accompany the final paper. Acceptable higher limit is 15 %.

PUBLICATION

The manuscripts will be subjected to the blind review process. The decision of the reviewer committee will be final. Selected papers received till the deadline will be published in the Rajasthan Economic association journal. Out of all papers received for the conference, a limited number of very high-quality papers will be published in UGC Care listed journals with an additional processing fee of Rs 3500 per paper. The best papers of the conferences will be published in Scopus listed journal.
