## GUIDELINES FOR AUTHORS

Rajasthan Economic Journal (REJ), published by Rajasthan Economic Association, is a bi-annual, double – blind, peer-reviewed, and refereed journal intended **to publish original** and unpublished **research papers in the field of economics**. The journal invites original and unpublished research papers. Manuscript for consideration for publication shall be sent by email attachment to [rajeconomicjournal@gmail.com](mailto:rajeconomicjournal@gmail.com).

## MANUSCRIPT SUBMISSION

1. The first page of the paper should include title of paper, the author details including the full name (without any prefix), designation, institutional affiliation with complete address (including PIN), email ID, and ORCID ID. The title of the paper should be in Times New Roman 14 point, right-aligned and author information should be in Times New Roman 12 point, and right-aligned. To maintain the integrity of the double-blind review process, the name or affiliation of the author(s) must not appear anywhere else in the manuscript.
2. The main manuscript should begin on the second page, starting with the title of paper, followed by the abstract, keywords (arranged in alphabetically), JEL Classification, and the main body of the paper. The title should be in Times New Roman, 14 point, bold, right-aligned. Subheadings should be in Times New Roman, 12 point, bold, left-aligned. The manuscript must be in MS Word format, typed in Times New Roman, 12 point, single-spaced, and justified. Abbreviations to be defined at first mention and used throughout the text. Annexures, if any, should be placed at the end of the manuscript. PDF submissions will not be accepted. The manuscript should not exceed 7,000 words, including abstract, main body, references, annexures, tables and figures.
3. The abstract should be fully italicized, single-spaced, justified, and typed in Times New Roman font size 12 point. It must clearly and concisely summarize the content of the paper by briefly outlining the study's

objectives, the methodology employed, and the main findings. The abstract should be written in the past tense and should not exceed 250 words. The use of abbreviations and references must be avoided. Following the abstract, a list of relevant keywords (arranged alphabetically) and at least three appropriate JEL Classification Codes should be provided.

4. Tables should be numbered consecutively as Table 1, Table 2, Table 3, and so on, rather than using sub-numbering formats like Table 1.1, Table 1.2, Table 1.3, and so on. The title of the table should be placed above the table and the source should be indicated below the table. Figures should be numbered consecutively as Figure 1, Figure 2, Figure 3 and so on and not as Figure 1.1, Figure 1.2, Figure 1.3 and so on. The title of the figure should be placed above the figure, and the source should be indicated below the figure, wherever necessary. All tables and figures must be presented in an editable format, numbered consecutively, and inserted within the main text. Mathematical formulas and equations should be typed clearly and numbered in a continuous serial order.
5. At the time of manuscript submission, the author(s) must provide a declaration on a separate page stating that the paper (1) is an original work of the author(s), (2) has not been published previously, and (3) is not under consideration for publication elsewhere. In the case of multiple authors, the corresponding author must confirm that all co-authors have reviewed and approved the manuscript's content and have consented to its submission to the REJ. The corresponding author represents all co-authors and is responsible for ensuring that any questions regarding the accuracy and integrity of the work are properly addressed. The editor of REJ will not be held liable for instances of plagiarism or copyright infringement; such responsibilities rest solely with the author(s). Additionally, author(s) must disclose any financial support received for the research and state whether prior permission to publish the paper has been obtained from the funding agency, if applicable.

6. When submitting a paper to the REJ, the submitting author must agree to pay the publication charge for publishing the paper and then, the reviewing process will start. Papers that meet the required quality standards during the preliminary check will then be forwarded to reviewers for evaluation.
7. Manuscripts not accepted for publication will not be returned to the contributors. Authors of rejected papers will be notified via email only, and the rejected manuscripts will be archived. Similarly, authors of accepted papers will also be informed exclusively through email.
8. All submitted manuscripts undergo an initial screening by the Editor, and those deemed suitable for the journal are forwarded for evaluation through a double-blind peer review process. Manuscripts are considered for publication based on (a) the reviewers' recommendations and (b) the author's or authors' satisfactory revisions in response to the reviewers' comments and suggestions, if any. Once accepted, all manuscripts are copy-edited and sent to the authors for final approval. Print page proofs are reviewed either by the authors or by the journal's editorial team to minimize communication delays and expedite publication. Both print and soft copies of the journal issue are provided to all contributing authors.
9. References should be listed at the end of the manuscript in alphabetical order, following the APA (7th Edition) style. They must be single-spaced, justified, and typed in Times New Roman font, size 12, with a hanging indentation. Only the works cited within the manuscript should be included in the reference list, and all listed references must be properly cited within the text.
